- 4. Application has to be submitted in the offline mode only alongwith non-refundable requisite fee of Rs. 300/- for each paper for which re-evaluation is being applied. Every application for Re-evaluation must be submitted alongwith a Cash Receipt/State Bank Challan of Rs.300/-for each paper.
