FOR ADMISSION TO MAHIR-E-TIB (DOCTOR OF MEDICINE)/ MAHIR-EJARAHAT (MASTER OF SURGERY)/ P.G. DIPLOMA IN ILMUL SAIDLA IN FACULY OF UNANI MEDICINE

The candidate who wishes to apply for admission to Mahir-e-Tib/Mahir-e-Jarahat/P.G. Diploma Courses in the Faculty of Unani Medicine is advised to carefully read the chapter titled 'General Information' given in the Guide to Admissions 2021-22 and additional information and rules as given in the Guide to Admissions (Supplement-U) which can be seen/downloaded from the Controller's Office Website:

It shall be presumed that the candidate applying for admission agrees to abide by the same.

ADDITIONAL INFORMATION AND RULES

- 1. **Definition of Internal/External**: An Institutional (**Internal**) candidate is one who has passed the qualifying examination conducted by THIS University as a regular student not earlier than THREE (03) academic years from the date of admission to the Course he/she is seeking admission to. And all other candidates shall be treated as **External**. The period of THREE (03) years will be counted from the date the candidate has completed the Internship.
- **2.** Counselling: All aspirants for admission to Mahir-e-Tib/Mahir-e-Jarahat/P.G. Diploma Courses are required to register themselves with AYUSH Admission Central Counselling Committee (AACCC), as soon as Registration Process is started by AACCC on its website:-www.aaccc.gov.in

Aspirants who are eligible for admission against Institutional (Internal) seats are also required to Register with AMU on its website www.amucontrollerexams.com. A separate Notice will be issued by the University for the same.

The University, in addition to counselling for Institutional (Internal) Quota seat, will also be conducting Final Mop up Round (Stray Vacancy Round), for vacant seats, if any. Only Institutional (Internal) Candidates will be eligible for participation in the Final Mop up Round (Stray Vacancy Round). A separate Notice/Schedule will be issued by the University for the same.

No candidate will be allowed to appear in the Counselling, unless he / she produces the following documents:

- Marksheets of BUMS Course passed (from First year to Final year)
- Certificate of completion of compulsory Rotatory Internship training for the period prescribed by the CCIM. Only those who will complete their Internship latest by 31.12.2021 are eligible for admission.

In case of incomplete Internship, a certificate issued by the head of the college/institution on his/her letterhead, mentioning the last date of completing the internship, must be submitted by the candidate (As per Annexure-I)

Permanent Registration Certificate (Provisional Registration Certificate may also be accepted subject to submission of Permanent Registration Certificate within three months from the date of admission.

NOTE: No candidate will be allowed to complete the admission requirements, unless he/ she produces the following document in addition to the above documents (all in original):

No Objection Certificate from the employer/ Institution where he/she is working /pursuing the PG Course.

- 3. The lists of candidates shortlisted for Counselling and the lists of those selected for admission will be displayed on the Notice Boards of the concerned Faculty / College / Proctor's Office / Controller's Office Website. The dates notified for Counselling/Admission shall strictly be followed. It is the responsibility of the candidate to keep himself/herself informed from Notice Board(s)/ website or through their own sources whether their names appear in the displayed lists and thereby make timely arrangements to appear for Counselling or for completing the admission, as the case may be. The University shall not be responsible if a candidate fails to get information regarding his/her shortlisting for Counselling or selection for admission.
- **4. Admission in other Discipline** / **Subject**: A candidate possessing Mahir-e-Tib / Mahir-e-Jarahat Degree in one subject of Unani Medicine shall not be allowed to get admission for next five years in any other subject of Unani Medicine for Mahir-e-Tib / Mahir-e-Jarahat Course. However, this condition shall not apply for P.G. Diploma course students.
- 5. Conditions for Leaving the Course:
 - If a candidate admitted to the Mahir-e-Tib / Mahir-e-Jarahat / P.G. Diploma in Ilmul Saidla Course leaves before completion of the Course or after final round of Counselling, he/she shall not be eligible for Counselling/admission to Mahir-e-Tib / Mahir-e-Jarahat / P.G. Diploma in Ilmul Saidla Course in the Faculty of Unani Medicine of this University. Further, he/she will have to pay Rs. 01 Lac (Rupees One Lac) as penalty and also return the stipend in full received from University or from any government source.
- **6. Duration of Study**: The duration of stay required by a candidate admitted to Mahir-e-Tib/
 - /Mahir-e-Jarahat Course shall be of 36 months and for P.G. Diploma shall be 24 months. The duration of stay shall be counted from the date of joining the course after completing admission formalities. The attendance requirement shall be 80% in each academic year separately.
- 7. Stipend: The stipend payable to a candidate shall in no case exceed 36 months for Mahire-Tib / Mahire-Jarahat students and 24 months for P.G. Diploma students (if applicable).
- 8. Absence and Name Removal: The name of a student may be removed on account of:
 - His/her own request in writing to the Dean, Faculty of Unani Medicine submitted through the Chairman of the Department concerned subject to the payment of penalty of Rs.01 Lac (Rupees One Lac) and refund of stipend and submission of a certified proof of valid reason for leaving the course.
 - Non-payment of arrears, by the Dean, on the recommendation of the Provost of Hall where the student is residing after being given appropriate notice and reasonable opportunity to pay the fees / dues of the University / Hall of residence/College library or Seminar/Hospital.
 - Gross misconduct by order of the Competent University Authority.
 - Continuous absence for one month from the class or Clinical / Lab duties without obtaining prior leave. In such a case, the Chairman of the Department will give a notice to the student at his/her residential or permanent address by registered post asking him/her to resume
 - his/her duties within a period of 15 days from the date of issue of the registered letter; and if the scholar fails to resume his/her class / duties within the time granted, the Chairman of the Department shall recommend to the Dean, Faculty of Unani Medicine for removal of the name of the scholar with immediate effect.
- 9. Bond: The admitted candidates, on joining the Departments, shall have to execute a bond containing text as prescribed by the University on non judicial stamp paper within 15 days of the notification by the Dean, Faculty of Unani Medicine, failing which their admission may be cancelled.
