NOTICE

The Ordinances (Academic) regarding re-evaluation of answer books of Secondary School Certificate (Class X)/Senior Secondary School Certificate (Class XII) Examination have been notified vide D.No.XM/ORD/01 dated 31.07.2020 Accordingly application for re-evaluation can be submitted only in the ONLINE MODE. Students are advised to go through the following procedure carefully before applying for re-evaluation:

Senior Secondary School Certificate Part II (Class XII) Examination 2025

Note : Re-evaluation of answer-book will be permitted in any One theory paper of which Examination have been conducted.

1. Student has to first log in to the University website:
<https://results.amucontrollerexams.com/oepls/login.php> and then register for re-evaluation.
2. Re-evaluation will not be permitted in more than one-fourth of the total theory papers of the examination in which the candidate has appeared.
3. There will be no re-evaluation in case of practical, viva-voce examination, field work, project work, periodic tests, online examinations, test, and sessional of all courses. Re-evaluation is also not permissible in answer books for compartmental examinations.
4. Application has to be submitted only in the online mode along with a non-refundable requisite fee of Rs. 300/- for each theory paper for which re-evaluation is are being applied. The student should keep ready his/her Net Banking/Debit Card/Credit Card details and follow the instructions available on the website to make payment.
5. The application for re-evaluation is submitted electronically the moment the student makes the payment of the requisite fee and payment is successful. There is no need to submit the hard copy of the Application Form.
6. No corrections are allowed after submission of the online fee for re-evaluation. It should be kept in mind that the requisite fee for re-evaluation will not be refunded under any circumstances.
7. The last date to apply for re-evaluation of the answer book for the Senior Secondary School Certificate (Class-XII) Examination 2025 is **06.05.2025**.
8. The result of re-evaluation shall be final and binding on the candidate, and no complaint or appeal against the revised award shall lie in any Court of Law, nor will the candidate claim any privilege deviating from the existing Ordinances, rules, and regulations. A declaration to this effect shall be deemed to have been signed electronically by the candidate while applying for re-evaluation.
