Aspirants for admission to various Courses under Self Financing Scheme (SFS), 2024-2025 notified vide D. No. 2580/Adms dated 20.06.2024

As per Clause 32 under IMPORTANT INFORMATION AND RULES of the Guide to Admissions 2024-2025 the following was notified:

In some of the courses of studies there is provision for supernumerary "SELF FINANCE SEATS (SFS)". The details of all such Courses of Studies, number of seats earmarked under SFS, the chargeable fee and / or the admission procedure will be notified separately. The desirous candidates are advised to keep track of all such notices.

The University vide Office Letter D. No. 2580/Adms. dated 20.06.2024 had notified supernumerary seats in various courses of studies under SFS. In this context, the following is clarified:

- 1. Only those candidates who figure in the Select List / Chance Memo List of the course concerned will be eligible for admission under this provision.
- 2. In all such courses, the supernumerary SELF FINANCE SEATS will be available to the candidates as a separate choice, in addition to regular seats, at the time of counselling.
- 3. The candidate can opt only for regular seats as was done previously. Alternatively, he/she can also opt for supernumerary SELF FINANCE SEATS if desirous of taking admission against them in a sequence as per his/her choice to be submitted at the time of counselling.
- 4. While allocating / upgrading the Course / Branch / Subject / Stream / Centre by the University, the candidate shall be considered on only those choices (including supernumerary SELF FINANCE SEATS) which the candidate had submitted at the time of choice filling during the counselling from the available choices applicable for the concerned course.

In view of the above, no fresh Application Form will be required to be filled up by the candidates for admission under SFS.

The Fee Structure for the courses being offered under Self Financing Scheme (SFS), 2024-2025 is being notified separately.
