5. Candidates applying for re-evaluation shall have to surrender their original marks

6. The last date to apply for re-evaluation of answer book of above mentioned course is 25.8.2025, and your application for re-evaluation should reach the Office of the Controller of Examinations latest by the said date, failing which the application will not be considered.
